SUBJECT: CHANGES TO RTGS PAYMENTS DETAILS

Dear Customer,

This is to inform you that effective 6th September 2024, Bank of Africa Kenya will introduce a mandatory "**Purpose of Payment**" field for all local RTGS payments. This is in line with the anticipated ISO 20022 standards, aligning with international financial message exchange protocols.

When making payments via branches or our BOAweb platform, you will be required to indicate the purpose of the payment using the provided purpose codes list:
